Resolución 8535/2008

Deniéganse el pago de compensaciones solicitadas en el marco de la Resolución Nº 9/2007 del Ministerio de Economía y Producción.

VISTO:

El Expediente Nº 29041DQE5 del Registro de la OFICINA NACIONAL DE CONTROL COMERCIAL AGROPECUARIO, y

CONSIDERANDO:

Que por la Resolución Nº 9 de fecha 11 de enero de 2007 del ex MINISTERIO DE ECONOMIA Y PRODUCCION se creó un mecanismo destinado a otorgar compensaciones al consumo interno a través de industriales y operadores que vendan en el mercado interno productos derivados del trigo, maíz, girasol y soja.

Que Mediante la Resolución Nº 378 de fecha 17 de enero de 2007, modificada por las Resoluciones Nros. 674 de fecha 24 de enero de 2007, 11 de fecha 9 de marzo de 2007, 339 de fecha 10 de abril de 2007 y 3043 de fecha 21 de agosto de 2008 todas de la OFICINA NACIONAL DE CONTROL COMERCIAL AGROPECUARIO, se estableció el procedimiento para la determinación de la compensación para la industrialización de trigo destinado al mercado interno implementado por la citada Resolución Nº 9/07.

Que la referida Resolución Nº 378/07 y sus modificatorias fijaron sus parámetros para la determinación y pago de las correspondientes compensaciones, resultando beneficiarios los molinos harineros, usuarios de molienda de trigo y productores de trigo.

Que por medio de la Resolución Nº 11 de fecha 9 de marzo de 2007 de la OFICINA NACIONAL DE CONTROL COMERCIAL AGROPECUARIO modificatoria de la mencionada Resolución Nº 378/07, ha establecido en su Art. 1 que: "Sustitúyese el Artículo 3º de la Resolución Nº 378 de fecha 17 de enero de 2007 de la OFICINA NACIONAL DE CONTROL COMERCIAL AGROPECUARIO organismo descentralizado en jurisdicción de la SECRETARIA DE AGRICULTURA, GANADERIA, PESCA Y ALIMENTOS del MINISTERIO DE ECONOMIA Y PRODUCCION, el que quedará redactado de la siguiente manera: "ARTICULO 3º - Los interesados, tanto al momento de exteriorizar su voluntad de incorporarse al mencionado mecanismo como al momento de que se proceda a la liquidación de la compensación, deberán: a) En el caso de los productores que pretendan incorporarse al mecanismo de compensación deberán encontrarse, inscriptos en el 'Registro Fiscal de Operadores de la Compraventa de Granos y Legumbres Secas' establecido en la Resolución General Nº 1394 de fecha 12 de diciembre de 2002 de la ADMINISTRACION FEDERAL DE INGRESOS PUBLICOS. A los efectos de la presente resolución se entenderá por productor al sujeto que desarrolla la actividad agrícola consistente en la obtención de trigo, mediante la explotación de un inmueble rural, ya sea de su titularidad, o bajo alguna de las formas establecidas por la Ley Nº 13.246 y sus

modificaciones, de arrendamiento rurales y aparcería".

Que los solicitantes detallados a fojas 3/15, y que según surge de las constancias de AFIP que se encuentran glosadas en cada uno de los expedientes que se agregaron al presente y que se detallan a fojas 16/22, si bien se encuentran inscriptos de forma ACTIVA en el Registro Fiscal de Operadores de Granos, no poseen declarada en el mismo, la actividad correcta en el mencionado Organismo, esto es, el cultivo de trigo ni el cultivo de cereales, como lo establece la Resolución General Nº 1394 de fecha 12 de diciembre de 2002 de la ADMINISTRACION FEDERAL DE INGRESOS PUBLICOS, por lo que corresponde la denegatoria de las solicitudes oportunamente presentadas y que se detallan a fojas 3/15.

Que en razón a lo establecido por la Resolución Nº 373 de fecha 10 de enero de 2008 de la OFICINA NACIONAL DE CONTROL COMERCIAL AGROPECUARIO, las solicitudes de compensación que por la presente se proceden a denegar, así como las que en su futuro corran la misma suerte en razón a las manifestaciones anteriormente expresadas, deberán ajustarse a lo establecido en el Artículo 3º de la citada Resolución Nº 373/08 el que establece que: "A partir del 1 de enero de 2008, las solicitudes de compensaciones podrán ser ingresadas en cualquier momento del mes, admitiéndose sólo UNA (1) presentación mensual por período a compensar, la que deberá encontrarse respaldada con toda la documentación que acredite las operaciones de conformidad con la normativa vigente, es decir, en forma completa", de lo que se desprende que no podrán presentarse nuevamente para su pago los formularios que ya han sido denegados por las razones que correspondan, quedando sin embargo expedito el derecho de los administrados de proceder según lo establece el Artículo 84 del Decreto Nº 1759/72 (T.O. 1991), que manifiesta que: "Podrá interponerse recurso de reconsideración contra todo acto administrativo definitivo o que impida totalmente la tramitación de reclamo o pretensión del administrado y contra los interlocutorios o de mero trámite que lesionen un derecho subjetivo o un interés legítimo. Deberá interponerse dentro de los diez días de notificado el acto ante el mismo órganos que lo dictó, el cual será competente para resolver lo que corresponda, conforme a lo dispuesto por el artículo 82".

Que el Area de Compensaciones de la citada Oficina Nacional evaluó las presentaciones efectuadas de acuerdo a la normativa vigente, conforme surge de fojas 1.

Que la Coordinación Legal y Técnica de la OFICINA NACIONAL DE CONTROL COMERCIAL AGROPECUARIO, no ha presentado objeciones a las denegatorias de las solicitudes efectuadas.

Que el suscripto es competente para dictar el presente acto administrativo en virtud de las

facultades conferidas por el Decreto Nº 1067 de fecha 31 de agosto de 2005 y por la Resolución Nº 9 de fecha 11 de enero de 2007 del ex MINISTERIO DE ECONOMIA Y PRODUCCION.

RESUELVE:

Art. 1 - Deniéganse las solicitudes presentadas por los productores de trigo que se detallan en el Anexo que forma parte integrante de la presente medida, por haber infringido lo establecido en la Resolución Nº 378 de fecha 17 de enero de 2007 de la OFICINA NACIONAL DE CONTROL COMERCIAL AGROPECUARIO y sus modificatorias, y en la Resolución General Nº 1394 de fecha 12 de diciembre de 2002 de la ADMINISTRACION

FEDERAL DE INGRESOS PUBLICOS, ya que si bien los operadores se encuentran inscriptos en el Registro Fiscal de Operadores de Compraventa de Granos y Legumbres Secas, no han declarado la actividad de cultivo de trigo.

Art. 2 - Hágase saber a los solicitantes que contra la presente resolución proceden los recursos previstos en los Artículos 84 y 90 del Reglamento de Procedimientos Administrativos, Decreto Nº 1759/72 T.O. 1991.

Art. 3 - Notifíquese a los interesados en los términos del Artículo 39 del Reglamento de Procedimientos Administrativos, Decreto Nº 1759/72 T.O. 1991.
